A quorum being present, the chair called the meeting to order at 4:08 p.m. Ms. Nalty moved for approval of the minutes of April 9; with a second by Dr. Frampton. The minutes were approved unanimously.

Dr. Cowan read an opening statement detailing the ERB's review process, the purpose of today's meeting, and the process by which public comments would be received this afternoon. Following the reading of the statement, the board received public comments.

At 4:44 p.m., Dr. Frampton moved that the board recess into executive session with a second offered by Ms. Nalty. The motion was approved unanimously.

At 5:33 p.m., the board resumed the public meeting on motion by Ms. Nalty and a second by Dr. Frampton. The motion passed unanimously.

Dr. Rouzan moved to reappoint Inspector General Edouard Quatrevaux for a second four-year term; a second was offered by Rev. Frampton. Dr. Rouzan acknowledged the concerns articulated by those speaking in opposition to reappointment and the chair lauded the efforts of Mr. Quatrevaux since his tenure began. The motion passed unanimously by a vote of 4-0.

Rev. Frampton moved that the board adjourn at 5:38 p.m.; a second was offered by Ms. Nalty. The motion was approved unanimously.
